

EDUCATION IN CRISIS: A LIBERAL WAY FORWARD

14 - 26 August 2022

Gummersbach, Germany

Abstract

"Without education, freedom does not withstand the test of time. Without freedom, there is no good education. Education and freedom of choice of educational paths are the foundation on which everyperson is empowered to develop their talents. For the benefit of all." (FNF)

Liberals all over the world express concern at the poor quality of education which will be amplified by a pace of technological and economic development never experienced before. Today's realities demand radical changes in education policies that do not seem to be forthcoming. Poor education means being unable to seize the full potential of opportunities being created, being left behind and even means exacerbating the inequalities that exist in society. What do we need to do to enable stakeholders to ensure modern, well-financed and sustainable education systems? And how do we do this keeping core principles and values of liberalism at the centre?

The last 2 years of the pandemic have made more visible the cracks in school education globally - both at the level of the education providers and at the level of the education system. Children across the world were thrust into the virtual world, many without access/ sufficient support. Teachers were expected to overnight become masters of engaging and educating children in an entirely new way. Schools were the last places to open up severely impacting the social and physical health of children raising questions about the soundness of government policy. At the same time, we also experienced unexpected resilience, faster coordinated government action, innovation in teaching that perhaps also have shown what could be possible for the future.

OBJECTIVES

In the 2-weeks seminar, the participants will articulate why education is, and should be, a central concern of liberalism and a priority in liberal policy-making. Participants will discuss and refine their understanding of a liberal concept of school education.

Participants will also take a deeper look into the historical and desired goals of school education and develop a systematic analysis of the interests and impact of key stakeholders on the design and delivery of education.

Finally, they will analyse their country/ region's educational successes and challenges from the liberal lens and have a broadened perspective of global education policy and practice. This provides them with inspirations and recommendations for improved policies and education delivery in their own countries/ regions.

TOPICS

This seminar covers the most critical discussions about primary and secondary school education. This includes:

Where is the world headed? - what are the key opportunities and threats for education design and delivery emerging from key trends in politics, economics, society?

Why schools? - are they meant to support self-fulfilment, engaged citizenry, or socio-economic progress? Are they designed to make children ready for the world or to create innovators and game changers? Is character building a desirable objective and how are schools achieving this?

How does this look in a historical and cross-country / cross-cultural perspective? What are the relevant education principles and philosophies that influence policy and practice?

What are the institutional arrangements that ensure that all children enjoy education opportunities and chances of upward mobility while also providing sufficient support and nurturing to gifted children? This touches on questions regarding social integration through school education, the respective roles of private and public schools, school finance and management, and also takes regional and country perspectives into account.

How to ensure educational freedom and choice for all households? This addresses the autonomy of parents and communities and includes a discussion of religious freedom in education.

What constitutes quality of learning? - who decides on the content of the curriculum and makes sure that it transitions from input-driven to outcome-oriented education? How are these outcomes measured in an international comparison? Where does edutech fit in and allows for an adjustment to new consumption behaviours.

TARGET GROUP

Liberal politicians and think tank members specialising in education policy, leading members of the educational profession and journalists covering educational issues. Participants must have a track record as liberals, seek reform in education and are open to unconventional approaches.

METHODOLOGY

The seminar will be an engaging and interactive experience. Participants will immerse themselves in the dialogues through role plays, debates, facilitated conversations using visuals constantly bringing in stakeholder perspectives, in particular parents, teachers/educators, students, and policymakers. The variety of methods used aim to challenge and elevate the thinking in the group. Experts will be invited

to engage with participants in discussions of particular challenges and solutions. An excursion to another city will exemplify German experiences with reforming school education.
