Wolf-Dieter Zumpfort studied economics in Bonn from 1968 until 1972 and received his doctorate at Kiel University in Economic and Social Science in 1976. After working at the Kiel Institute for the World Economy and the Landesbank Schleswig-Holstein he was a Member of the German Bundestag (MdB) for the Free Democratic Party (FDP) from 1979 to 1983. He was then the Chairman of the Schleswig-Holstein Executive Committee of the FDP until 1988, the Managing Director of the business association Westküste from 1983 to 1987 and the Leader of the FDP parliamentary faction and Member of Parliament in Schleswig-Holstein (MdL) from 1987 to 1988. After working as a consultant, Dr. Zumpfort moved to Hannover in 1990 and was Director for Preussag and later TUI AG. He headed the TUI AG Liaison Offices in Bonn, Berlin and Brussels until 2010. From 2010 until 2013 he was Head of the TUI Corporate Office in Berlin.

Dr. Zumpfort is Member of the Executive Board of the Friedrich Naumann Foundation for Freedom since 1995.
